**SUMMARY & BACKGROUND**

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

**ARP-ESSER Application – Part 1:** The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

**ARP-ESSER Application – Part 2:** The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. **APPLICATION PROCESS FOR LEA ALLOCATIONS OF ARP-ESSER SEA RESERVE FUNDS**

The federal ARP statute requires SEAs to reserve:

not less than 5 percent of the total amount of grant funds awarded to the State (\$449.4 million) to carry out activities to address the impact of lost instructional time by supporting the implementation of evidence-based interventions;

not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based summer enrichment programs; and

not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based comprehensive afterschool programs.

Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. An SEA must allocate at least 90 percent of its ARP ESSER grant funds to its LEAs (including charter schools that are LEAs) in the State in the same proportion that the LEAs received under part A of title I of the ESEA in Fiscal Year 2020, as required by section 2001(d)(1) of the ARP Act; and section 2001(e) of the ARP Act prescribes certain mandatory and permissive uses of LEAs' funds. Under 20 U.S.C. 1221e-3, the Secretary has the authority to promulgate rules governing the programs administered by the Department. In developing the district's plan for the use of the ARP ESSER funds a variety of groups and committees in the district were contacted to determine what needs have arisen out of dealing with the impact of COVID on our schools. Groups contacted included the PTA, the Professional Development Committee, the STEAM Committee, department coordinators, student congress and administrative council. Each group discussed the impacts of COVID on various aspects of learning and proposed possible solutions that could be funded through the grant.

The progress of the plan will be reviewed with the various groups listed above throughout the year. Feedback from each group will be reviewed by administration and integrated into the plan as appropriate. An end-of-year review will be held in June where members of all constituent groups will get together to review how the plan went during the current school year and will make additional adjustments as needed.

In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.**

In order to limit the spread of COVID in our schools, the district will be purchasing personal protective equipment such as masks, gowns and gloves. These items were effective in protecting our staff and students from possible COVID exposure. We will also be continuing our cleaning and disinfecting protocols to reduce the possibility of spreading the virus. To this end we will be buying cleaning materials such as disinfectant sprays, antibacterial wipes and cleaning solvents.

As a way to add an additional layer of protection from the spread of COVID when students are eating, the district will be purchasing some picnic tables to enable students to eat outside when the weather is agreeable. These tables can also be used for outdoor instruction for classes.

The district will use various assessment tools including the Renaissance STAR diagnostic program, Fountas & Pinnell reading assessments and other standardized tests to assess student learning and identify any needs. Teachers have also created some grade level or department wide assessments in a variety of subject to help determine any deficits. The assessment tools listed above as well as incremental assessments will be used to monitor student progress and to identify additional areas where students may need support.

The effectiveness of both the 2022 summer program and the online tutoring program in helping students make up any learning deficits from their time in remote and hybrid learning will be assessed using the New York State assessments as well as the teacher-created grade level and department wide assessments. The instructional changes that will be generated by the consultant work of Innovative Designs for Education will be evaluated using the Renaissance STAR, Fountas & Pinnell and New York State Assessments. These measures will help determine how much learning growth the students have experienced in English Language Arts and mathematics due to the changes in pedagogy.

To address the impact of lost instructional time on our students' learning, the district will be implementing several programs. As a continuation of the program that was offered in the summer of 2021, we are planning on offering a summer learning program in the summer of 2022. This program would reinforce the main topics taught in grades Kindergarten through 5th.

Additionally, we are looking to connect with the virtual tutoring company iTutor to provide virtual tutoring for students who need additional supports in some content areas. These sessions would be available to students at all grade levels.

In order to strengthen our teacher's ability to differentiate learning and target interventions effectively, they will be working with a consultant from Innovative Designs for Education. This company has assisted our teachers in changing the way that they approach learning in regards to making student growth and student empowerment the centers of learning. They will help our teachers accurately assess any learning deficiencies and design activities that will alleviate them.

The interventions that the district plans on using will support our student's social emotional needs through providing support to student who are struggling. The summer session will include lessons that are centered on SEL as well as regular content. The coaches from Innovative Designs for Education will help teachers integrate SEL supports into their learning and create targeted interventions for students of all needs.

As many of our low-income families do not have the financial resources to provide supplemental learning opportunities for their children should they need additional support, the district will establish a summer learning program at no cost to families. The district will also establish an online tutoring program as part of its ARP-ESSER plan in order to provide these students with additional help during the school year. Computer resources will be made available to these families as well if needed in order to take advantage of the online tutoring.

We have been working with consultants from Innovative Designs for Education (IDE) for several years with the goal of diversifying our instruction to meet the varying needs of our students. Teachers are working on personalizing the learning experience for each child and meeting the child where they are instructionally. Much of this work centers on aiding our English Language Learners and children with disabilities to achieve success in our classrooms. The IDE consultants work with our general education, special education and ENL teachers to develop multifaceted lessons that have scaffolds and supports for all learners. These lessons also have supports for students who accel at learning and need additional challenges.

In addition to instructional differentiation, our IDE consultants are also helping us explore cultural diversity. We are working to provide more inclusive instruction that acknowledges the cultures of all students including students of color. The IDE consultants have been a key component to this work and continue to challenge our teachers' perceptions in terms of bias in instructional materials.

The district currently has no students who are experiencing homelessness, children in foster care or migratory students.

Comments will be collected by the District Clerk and will be shared with the final review committee that will integrate these into the overall plan.
